ADVERTISEMENT

Koldam Hydro Power Station is first hydro power station of NTPC Ltd.(Govt. of India Undertaking), Situated at Distt. Bilaspur Himachal Pradesh and invites applications from ITI-Passed candidates for trade apprenticeship training under Apprentices Act- 1961 read in conjunction with Apprenticeship Rules 1992. A total number of 15 (Fifteen) vacancies as per distribution of vacancy details given below:-

2. Reservation of vacancies:

- a) **SC/ST, EWS &, OBC [NCL]** : Vacancies for SC/ST,EWS & OBC [NCL] candidates are reserved in accordance with Section 3A(1) & (2) and Section 3B (1) & (2) both of Chapter II of Apprentices Act-1961 read with Schedule II A of Rule 5 of Apprenticeship Rules 1992.

3. Eligibility Condition:

- a) Indian Nationals belonging to the states of Himachal Pradesh are eligible only.
- b) **Qualification:** Matric/Std. X with a minimum of 50 % [aggregate] marks for UR/OBC [NCL]/EWS candidates and 45 % [aggregate] marks for SC/ST candidates & ITI Examination in relevant Trade with aggregate of 60% marks qualified from NCVT [National Council for Vocational Training].
- c) Candidates who have passed ITI on or after **01.03.2019** only are eligible (Candidates should not have completed three years after passing of the qualifying examination). Students who have appeared for final year examination and awaiting results may also apply, however, their engagement shall be subject to qualifying the essential Equivalent qualification and production of Certificate.
- d) **Age:** Minimum **18 years** and Maximum **25 years** as on 31.03.2021. Relaxation in upper age limits as per Government guidelines for OBC [NCL]/SC/ST candidates.

- e) **Previous Training:** Candidates who have already undergone or are currently undergoing Apprenticeship training under Apprentice Act, 1961 in any Govt./Public Sector/Private Industrial organization **are NOT eligible to apply** for the current enrollment.
- f) As provided under the Apprentices Act, candidates, who had training or job experience for a period of one year or more after the attainment of essential qualifications, shall not be eligible for being engaged as Apprentice.
- g) If the mark sheet provides CGPA, it will be incumbent on the applicant to provide the marks, based on the conversion criteria mentioned in the guidelines issued by the University/Board/AICTE as appropriate

4. Payment of Stipend to Apprentices: The minimum rate of stipend per month payable to apprentices shall be as per Rule 11 of Apprenticeship Rules, 1992 is relevant and subsequent amendments thereafter.

5. Selection Procedure: Selection of the candidates will be on merit basis i.e. on the basis of marks obtained in Metric & ITI marks.

6. CERTIFICATE OF MEDICAL FITNESS (to be obtained only from a Gazetted Government Medical Officer/Medical Officer of a Government Undertaking) to be submitted at the time of joining.

7. Police verification certificate to be obtained from local area of residence.

8. The shortlisted candidates will be called for interview/Document verification through their registered E-mail Id only.

9. Accommodation: Selected candidates will have to make their own arrangements for accommodation during Apprenticeship period.

10. Applications:

Application must be submitted through registration link <https://webapp.ntpc.co.in/Koldam>. The applications should be accompanied by copy of [a] SSC Board certificate/Matriculation Mark Sheet and proof of date of birth [b] ITI pass Certificates and marks sheets [c] Caste Certificate [for SC/ST/OBC [NCL]/EWS only] [d] Aadhar Card and PAN card (**Compulsory**). e) Land Oustee Certificate

The application must be submitted on or before on or before **24.06.2021**. Incomplete applications **will be rejected** and no further correspondence in this regard will be entertained.

11. Employment: As per Apprentices Act, 1961, **it shall not be obligatory for Koldam HPS to employ Apprentices on completion of training. There are no provisions for providing direct employment in NTPC Ltd. on completion of Apprenticeship training.**

12. GENERAL INSTRUCTIONS:

- a. Last Date of receipt of application is **24.06.2021**.
- b. Candidates are advised to carefully read the entire advertisement for details of educational qualification and other eligibility criteria before submission of application.
- c. Applications without supporting documents/incomplete/not fulfilling the prescribed criteria in any respect shall be rejected.
- d. Candidates applying for more than one Trade will not be considered and their application will be rejected.

- e. Candidates should register themselves in the concerned web portal (apprenticeshipindia.org) prior to applying for apprenticeship training without fail. Correspondence/Communication in any other manner will not be entertained.
 - f. Request for change in mailing address/ category/ discipline/ qualification once declared during registration on NATS/ Koldam HPS web portal will not be entertained.
 - g. Applications received through online portal will be considered, till the last date of application as per advertisement only. No application shall be considered thereafter. However, selection shall be strictly on the basis of merit/rank and meeting all eligibility criteria.
 - h. The number of candidates to be engaged is indicative and may undergo changes as per requirement without any further notification.
 - i. During the period of apprenticeship training, candidates will be governed by the Apprentices Act, 1961 (as amended from time to time thereafter) and the policies/rules of the organization.
 - j. At any stage of the selection process, if it is found that the candidate has furnished false or incorrect information, then the candidature/engagement of the candidate is liable to be cancelled.
 - k. Koldam Hydro Power Station, NTPC Ltd. has no obligation to give regular employment to Apprentices. Candidates shall have no right to claim regular employment from NTPC Ltd. on the basis of this apprenticeship training at any point of time. NTPC management is not liable for any sort of employment/placement.
 - l. The decision of Koldam HPS Management will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the application, mode of selection, cancellation of the selection process either in part or full, etc. No correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of the Koldam HPS management based on suitability of candidates and no claim will be entertained, if some of these seats are not filled due to unsuitability/insufficient number of candidates.
 - m. In case no application is received from suitable/ eligible candidates by last date, Koldam HPS shall take apprentices directly from apprenticeshipindia.org portal.
 - n. Koldam HPS Management is not answerable to the candidate for non-selection.
 - o. It shall be the sole responsibility of the candidates to get their profile verified from the respective RDSDE, Shimla PORTAL.
