The said information has been communicated vide letter no. MSDE(DGT)-4/14/2014-16-CD (Pt-II) dated 20th July, 2016. However, the same is once again enclosed

This opportunity can be availed by both fresh ITI batch students and as well as ITI passed out candidates. It means that fresh batch trainees while under going ITI training, he/ she can parallely register and may appear for two subjects as prescribed by NIOS. Once, he/she completes ITI courses, can submit the ITI certificate along with mark sheet of passed two NIOS subjects to get the consolidated mark sheet of academic 10th/12th qualification. Hence, at the beginning of every training session, Principal/trade instructor to apprise about the option and motivate them to register on NIOS website at https://www.nios.ac.in/ for any two subjects as prescribed by NIOS.

It is further requested to get closer liaison with Regional Centre of NIOS to make enrolment of ITI candidates and also to conduct various awareness workshops at the state level for the better implementation of the scheme. In this regard, RDSDEs/NSTIs of DGT also have to play a major role in making closer liaison with state Directorates and as well as Regional Centres of NIOS.

You are requested to circulate this office order to all ITIs in your State/UTs and to give wide publicity in this matter for the career progression of ITI candidates
