PUBLIC NOTICE

It is brought to the notice of general public that Department of Technical Education is inviting applications/proposals for opening of new Pvt. ITI's from session 2022-23. The interested applicants viz. individual/ Societies/ Trusts/ Private Limited Companies, ITI's etc. who want to start new NCVET ITI/ want to add more trades in existing ITI under National Council of Vocational Educational Training (NCVET) in Himachal Pradesh may submit their proposal as per "NCVET affiliation norms for ITI's" and DGT letter No. DGT-11012/4/2021-O/o DIR(TC) dated 04-08-2021 (copy enclosed) and other instructions issued from time to time, vide which all the new ITIs shall run with minimum 4 trades and 8 units with combination of at least 1 each from Engineering, Non-Engineering, New Age/ Industry 4.0 Trades along with application fee. The application fee of Rs. 10,000/- (ten thousand only) for 4 trades (maximum 8 units) and Rs. 12,000/- (twelve thousand only) for more than 4 trades (more than 8 units) will be charged from the applicants. The requisite application fee in the shape of "Demand Draft/Banker cheque" drawn in favour of Director Technical Education along with hard copy of the proposal will have to be submitted in the office of Directorate Technical Education Vocational & industrial Training Institute, Sundernagar, Himachal Pradesh on or before 31 January, 2022. The ITI,s opening /Affiliation norms can be downloaded from web portal [http://dgt.gov.in/sites/default/files/NCVT afiliation norms ITIs.pdf](http://dgt.gov.in/sites/default/files/NCVT%20afiliation%20norms%20ITIs.pdf) or www.nimionlineadmission.in/iti. The norms may be amended by DGT in future and fees may also be increased /decreased. The latest prescribed norms & fee/charges will be applicable in due course of time for session 2022-23.

Note:- The applications will be scrutinized initially as per norms and "NOC" to the eligible applicants will be issued by the State. Thereafter, individual/Societies/ Trusts/ Private Limited Companies, ITI's etc. will have to apply on Govt. of India web portal www.nimionlineadmission.in/iti. The applications/ proposal will be scrutinized for various requirements (civil, finance, infrastructure, electricity, availability of Map, Road etc.) at different stages by Govt. of India & H.P. State authorities i.e. Directorate of Technical Education. The application fee & process fee (inspection, site visit, re-visit etc.) will be levied by the DGT & State Govt. separately at various stages of application process.
