

Tenders will be opened on **12/04/2021** at **11:00 AM** at Principal's Office in the presence of bidders or their authorized representatives who may want to present. In case of holiday on that day bids will be opened on the next working day at same time schedule.

**Term & Conditions:**

**1. Eligibility for Bidders to Qualify Technically:**

- A) The bidder must have to submit experience certificate of last three financial years of Satisfactory Supply of similar nature to some Govt./Semi Govt. Organization or State/Central PSU/private firms.
- B) The bidder has to submit an **earnest money of Rs. 10000 (Rupees Ten Thousand only)** in the shape of DD or FDR duly pledged in favour of **Principal-cum-Member Secretary, IMC of Govt. ITI Rajgarh**. EMD of unsuccessful bidder will be returned after finalizing the tender. The EMD of successful bidder will be adjusted for Performance Security and will remain in custody of undersigned for six months or upto warranty period. In case any bidder withdraws his offer after submission of tender undersign may forfeit the EMD in full. The bidders who have been exempted from submission of EMD will have to submit such documentary proof issued by competent authority.
- C) Copy of GSTIN of Bidder.
- D) Copy of PAN of Bidder.
- E) Non-Refundable Tender Document Cost in the Shape of Demand Draft of **Rs. 300/- (Rupees Three hundred only)** in favour of **Principal-cum-Member Secretary, IMC of Govt. ITI Rajgarh Distt. Sirmour (HP)-173101** payable at Govt. ITI Rajgarh.

**2. Preparation of Bids and Submission:**

- A) The tender should be submitted along with the Experience Certificate, Copy of GSTIN, Tender Document Cost and **Commercial Bid** (in form given in Annexure-A) and should be kept in a sealed cover addressed to the **"Principal-cum-member, IMC of Govt. ITI Rajgarh, Distt. Sirmour (HP)-173101"**. The outer envelope containing sealed cover should bear the address, Tender number and date, subject of tender, date and time of the opening the same.
- B) The rates should be quoted in **Commercial Bid** only **both in words and figures**.

**3. Evaluation of Tender:**

- A) Decision of Tender Opening Committee in this regard will be final and binding upon the bidders.
- B) The order will be placed to lowest bidders as-a-whole.

**4. Performance Security:**

EMD will remain in the custody of undersigned till completion of work awarded. The EMD of successful bidder already deposited will be adjusted in performance security and will remain in custody of undersigned till completion of work. In case of failure of completion of work/supply the undersigned reserve the right to forfeit the Security in full or part. The bidders who have been exempted from submission of Performance Security will have to submit such documentary proof issued by competent authority.

**5. Time for Execution of Work:**

The work of setup of Gym has to be complete within 30 Days from the issue of the Supply order.

**6. Penalty Clause:**

A penalty of 1% on billed amount will be imposed for late delivery or completion of work per week maximum up to 5%. In case of late delivery or work completion for more than 5 weeks the work may be awarded to second lowest bidder and the extra amount paid to second bidder/new supplier will be deducted from first bidder/old supplier.

**7. Delivery:**

The rates quoted should be F.O.R. at Govt. ITI Rajgarh Campus at Village Shamloh, Tehsil Rajgarh, Distt. Sirmour (HP).

**8. Specifications:**

Supply should be strictly in accordance with specifications mentioned in tender/supply order, any defective or substandard material will be rejected in whole and supplier has to take back the rejected material at his own cost. The material supplied must have warranty period of minimum 5 Yrs.

**9. Quantity:**

The Qty. Shown may be varied as per actual requirement of the institution. Final payment will be made as per actual measurement of work executed.

**10. Jurisdiction/Signing of Tender/Agreement:**

Conditional tenders or tenders without EMD will not be entertained in any respect. The undersigned reserves the right to reject any or all of the tenders without assigning any reason. No separate agreement will be made, this tender document will be treated as agreement between both supplier and buyer.
